- 1. The tenders (properly sealed with sealing wax/packing PVC tape in an envelope) are invited on behalf of BSNL Arunachal Pradesh SSA for disposal of Scrapped items/stores at various locations of Arunachal Pradesh SSA on "AS IS WHERE IS BASIS".
- 2. The interested persons/parties may inspect these items from **16/11/2019 to 08/12/2019** between11:00 Hrs to 15:00 Hrs with prior permission of the SDOT/SDE concerned.
- 3. The interested firms have to submit their quotation as per the format given in **Annexure-E** (in a properly sealed with sealing wax/packing PVC tape in an envelope). The envelope containing the Quotation should be super-scribed as "**Quotation for disposal of Scrapped items at various locations of Arunachal Pradesh SSA**".
- 4. The price to be quoted as per the prescribed format, both in words and figures in legible manner and should bear the signature and complete contact details (including mobile/telephone numbers) of the persons/parties. The rates must be quoted inclusive of all taxes, GST, duties and any other levies, etc. for each lot.
- 5. The basic rate of the items is given in **Annexure-F**.
- 6. The cost of each lot of material along with all taxes and duties must be paid by the buyer in one single installment within 15 days from the date of acceptance letter.
- 7. EMD of Rs. 5000/- in the form of DD/Banker Cheque should be submitted along with the auction bid document in favour of "AO (Cash), BSNL, Itanagar" payable at SBI, Itanagar.
- 8. Correction, if any, in the quotation is to be attested. The conditional quotations are liable to be rejected without further notice.
