- 1. The quotations will be submitted up to 3:00 PM on 19.06.2018 in this office as well as in the office of Sub-Divisional Engineer (Civil), BSNL Civil Sub-Division-I,1st Floor Qtr, DTO Compound, Imphal-795001 and will be opened at 3:30 PM on 20.06.2018 by the undersigned in this office.
- 2. Fair valuation will be done in prescribed proforma as on dated 01.04.2015.
- 3. The Valuer has to make his own arrangements for conveyance, lodging, boarding, apart from other logistic support for carrying out the valuation.
- 4. The valuer is expected to acquaint himself about the nature of works involved etc before submitting the quotation. If valuer desires to have any further information regarding details of plans etc, on the subject matter, can visit our office at the above address for the same.
- 5. The rate quoted should be all inclusive to complete the job in full including conveyance, lodging and boarding charges during their period of stay at respective places including secretarial charges and other incidental expenses for valuation of the said land assets. Further, in case of failure to submit valuation report due to whatsoever reasons, no charges of any kind shall be paid under any circumstances.
- 6. The rates quoted by the valuer/valuation agency shall be inclusive of all types of taxes/levies/duty by the Govt. including cess etc but excluding Service Tax. Nothing extra shall be paid over the Quoted rates. The Service tax shall be paid separately as per standing Government norms.
- 7. Payment will be released through e-transfer only after submission of valuation report in full, satisfactory to BSNL.
- 8. The Valuer is required to submit the final valuation report in duplicate as per the BSNL guidelines within 15 days from the date of issue of work order.
