INSTRUCTIONS TO BIDDERS

SERVICE TO BE PROVIDED

1. Service to be provided are given in Section VI

2. <u>Eligible Bidders</u> -

- (a) Bidders should be recognized from the Department of tourism, Govt. of India / State Govt / any other Public Institution/Body.
- (b) The bidder should own or on lease sufficient vehicles (minimum *****one) of model not older than year 2016 vehicle registered as commercial vehicles in their names or Firm's name for use as commercial vehicles. The proof of ownership or lease holding should be produced when called for.
- (c) The bidder shall also submit full details of the vehicles that can be assigned in their favour and shall give a clear declaration that the firm will be able to supply commercial vehicles of *model not older than 2016*
- (d) The bidder shall have experience of minimum period of 2 years for similar type of contract of supplying not less than one year cars to Govt. organization or any large Public Sector Undertaking.

3. <u>Cost of Bidding</u>

The bidder shall bear all costs associated with the preparation and submission of the bid. BSNL, in no case be responsible for this cost regardless of the conduct or outcome of the bidding process.

4. <u>Bid Document</u> -

- 4.1 Bid document includes
- a. Notice Inviting Tender
- b. Instruction to bidders
- c. General condition (Commercial) of the contract.
- d. Special conditions of contract if any.
- e. Schedule of requirement and Hire charges.
- f. Services to be provided
- g. Bid form and price schedule
- h. Bid security form
- i. Performance Security Bond Form
- j. Letter of authorization to attend bid opening.
- 4.2 The bidder is requested to examine all instructions, terms and specification in the Bid documents. Failure to furnish all information required as per Bid Documents or submission of the bids not substantially responsive to the Bid Documents in every respect will be at the bidder's risk and may result in rejection of the Bid.

- 4.3 A prospective bidder requiring any clarification on the Bid document shall notify the purchaser in writing. The purchaser shall respond in writing to any request for the clarification of bid document which it receives not later than 3 days period to the date of opening of Tender.
- 5. Documents required to be submitted for establishing Bidders Eligibility and Qualifications
 - i. The bidder shall furnish the particulars of past performance with supporting documents.
 - ii. Partnership Deed or proprietorship deed or articles/Memorandum of Association as the case may be, latest Annual Account in form /C6.
 - iii. Latest income Tax clearance certificate (ITCC)
 - iv. Valid and authenticated certificate from the Department of Tourism, Govt. of India/Nagaland State.

6. <u>Amendment to bid document</u>

- i) At any time, prior to the date of submission of bid, BSNL may, for reason whether at its own initiative or in response to a clarification required by a prospective bidder, modify the bid documents by amendments.
- ii) The Amendments shall be notified in writing to all prospective bidders and these amendments will be binding on them.

7. Documents comprising the bid

The bid prepared by the bidder shall comprise the following components.

- a. Documentary evidence established in accordance with clause 2 that the bidder is eligible to bid and is qualified to perform the contract if his bid is accepted.
- b. Bid security furnished in accordance with clause 11
- c. A clause by clause compliance as per clause 10
- d. Bid Form and price schedule completed in accordance with clause 8 and 9.

8. Bid Form.

The bidder shall complete the Bid Form and the appropriate price schedule furnished in the bid document covering the services to be rendered quality and price schedule as per Section-V

9. Bid Price –

- i) The supplier shall quote as per price schedule given in section V for all types of vehicles given in the schedule of requirement giving.
- ii) The price quoted by the bidder shall remain fixed during entire period of contract & shall not be subject to variation on any account. A BID submitted with an adjustable price quotation will be treated as non-responsive and rejected.
- iii) "Discount" or extra charges if any mentioned by the bidders shall not be considered unless these are specially indicated in the price schedule.

10. <u>Clause by clause compliance</u>.

A clause by – clause compliance of service to be provided (SECTION VI), and special condition (SECTION IV) shall be given. In case of deviation a statement of deviation shall be given.

11. <u>Bid Security</u>

- 11.1 Pursuant to clause 6, the bidder must deposit **Rs.10,000/-** (**Rupees Ten Thousand Only**) as Bid Security. The Bid Security shall be in the form of Bank Guarantee valid for 90 days from the date of tender opening may be submitted in separate cover.
- 11.2 The successful bidders security will be discharge upon the bidders acceptance of the award of contract satisfactorily in accordance with clause 15 and furnishing the performance security.

11.3 <u>The Bid Security may be forfeited</u> :

- a) If bidder withdraws his bid during the period of bid validity specified by the bidder in the bid form.
- b) If the successful bidder fails
 - i) to sign contract in accordance with clause 18
 - ii) to furnish performance security in accordance with clause 2 of section III
 - iii) A bid not secured in accordance with para 11.1 shall be rejected by the BSNL as non-responsive at the bid opening state and returned to the bidder unopened.
 - iv) The bid security of unsuccessful bidder will be discharged/returned as early as possible but not later than 30 days after the expiry of the period of bid validity.
- **12. Format and signing of Bid**. The bidder shall prepare one complete set of original bid and one copy of the same clearly marking "original" and 'copy'. In the event of any discrepancy, the original shall govern.
- 12.1 The original and copy of the bid shall be typed or printed and all pages numbered consecutively and shall be signed by the bidder or a person duly authorized to bind the bidder the contract.
- 12.2 The over writing /erasures in the bid made by the bidder shall be signed by the person signing the bid.

13. <u>Submission of bid</u>.

- i) The bids should be submitted duly sealed and addressed to the Executive Engineer (Civil), BSNL Civil Division-I, Dimapur and delivered in person on or before 15.00 hrs. of due date.
- ii) Any bid received after the dead line for submission of bids shall be rejected and returned to the bidder.

14. <u>Bid Opening</u>

BSNL shall open bids in the presence of bidders or their authorized representative who wish to be present at the time of opening of bids on due date. Authorization letter to this effect shall be submitted by the bidder before they are allowed to participate in bid opening (Format is given in section X).

15. <u>Evaluation</u>

- 15.1 BSNL shall evaluate the bids to determine whether they are complete, whether any computational errors have been made whether documents have been properly signed and whether bids are generally in order.
- 15.2 If there is a discrepancy between words and figures the amount in words shall prevail prior to detailed evaluation, BSNL will determine the substantial responsiveness of each bid to the bid document. A substantially responsive bid is one, which confirms to all the terms and conditions of bid documents without material deviation. A bid determined as substantially non-responsive will be rejected by BSNL.
- 15.3 BSNL shall evaluate in detail and compare the substantially responsive bids and comparison of bid shall be on the price of the services offered inclusive of all levies and charges as indicated in the price schedule in section V of the bid document.

16. <u>Award of Contract</u>

BSNL shall consider placement of letter of intent to those bidders whose offers have been found technically, commercially and financially acceptable. The bidder shall within 10 days of issue of letter of indent, give his acceptance along with performance security in conformity with section IX with the bid document.

17. <u>Right to vary quantities</u>

BSNL reserves the right at the time of award of contract to increase or decrease up to 25% of the required quantity of services specified in the schedule of requirements without any change in hiring charges of the offered quantity of other terms and conditions.

18. <u>Signing of Contract</u>

- 18.1 Signing of Agreement shall constitute the award hiring contract on the bidder.
- 18.2 Upon the successful bidder furnishing the Performance Security the BSNL shall discharge its bid security in pursuant to clause 11.

19. <u>Annulment of Award.</u>

Failure of the successful bidder to comply with the requirement of clause 18 shall constitute sufficient ground for the annulment of the award and forfeiture of the bid security in which event BSNL may make the award to any other bidder at the discretion of BSNL or call for new Bids.

- (i) The Bid shall remain valid for 90 days after the date of opening of bids. A bid valid for a shorter period shall be rejected by BSNL as non-responsive.
- (ii) A bidder accepting the request of BSNL for an extension to the period of bid validity, in exceptional circumstances, will not be permitted to modify his bid.

SECTION III

GENERAL CONDITIONS OF CONTRACT

1. <u>Application</u>

Submission of bid against this offer shall bind the bidder for the acceptance of all the conditions specified herein or in NIT unless otherwise agreed by BSNL.

2. <u>Performance Security</u>

- 2.1 The successful bidder shall be required to deposit an amount equal to 10% of the Tendered value subject to maximum limit of Rs. 5 lakhs within 2 weeks of conveying BSNL's intention for accepting the bid as Performance Security.
- 2.2 Performance Security shall be submitted in the form of Bank Guarantee issued by a scheduled Bank and the Performa provided in section IX of the bid document.
- 2.3 Performance Security will be discharged after completion of contractor's performance obligations under the contract.
- 2.4 If the contractor fails or neglects any of his obligations under the contract it shall be lawful for BSNL to forfeit either whole or any part of performance security furnished by the bidder as compensation for any loss resulting from such failure.

3. EXECUTION TIME LIMIT

3.1 The time period as stipulated in the contract or intent shall be deemed to be essence of the contract.

4. <u>PAYMENT TERMS</u>

Monthly bills shall be submitted in duplicate to the authority specified in contract along with duty slips duly signed by the user.

5. <u>Termination of contract</u>

- 5.1 BSNL may without prejudice to any other remedy for breach of contract may terminate the contract in whole or in parts.
- (a) If the contractor fails to arrange the supply of any or all of the vehicles within the period(s) specified in the contract or any extension thereof granted by BSNL.
- (b) If the contractor fails to perform any other obligation(s) under the contract.
- 5.2 BSNL may without prejudice, to other rights under law or the contract provided get the hiring of vehicles done at the risk and cost of the contractor, in above circumstances.

6. <u>Termination for insolvency</u>

BSNL may also by giving written notice and without compensation to the contractor terminate the contract if the contractor becomes unwilling, bankrupt or otherwise insolvent without affecting its right of action or remedy as hirer.

7. <u>Force Majeure</u>

7.1 If any time, during the continuance of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reason of any war, or hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts or act of God (Hereinafter referred to as events) provided notice of happenings, of any such eventuality is given by either party to the other within 21 days from the date of occurrence thereof, neither party shall by reason of such events be entitled to terminate this contract nor shall either party have any claim for damages against the other in respect of such on performance or delay in performance under the contract shall be resumed as soon as practicable after such an event may come to an end or cease to exist, and the decision of BSNL as to whether the supplies have been so resumed or not shall be final and conclusive, provided further that if the performance in whole or part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days either party may, at his option terminate the contract.

8. <u>Arbitration</u>

- 8.1 In the event of any question, dispute or difference arising under the agreement or in connection there with (except as to matter the decision to which is specifically provided under this agreement), the same shall be referred to *sole arbitration of the Superintending Engineer(C) BSNL NE-II Civil Circle Dimapur*. in case his designation is changed or his office is abolished then in such case to the sole arbitration of the officer for the time being entrusted whether in addition to the function of theor by whatever designation such officers may be called (hereinafter referred to as the said officer) and if theor the said officer is unable or unwilling to act as such, than to the sole arbitration of some other person appointed by the Chief Engineer (Civil), Dimapur or the said officer. The agreement to appoint an arbitrator will be in accordance with the Arbitration and Conciliation Act, 1996.
- 8.2 The arbitrator may from time to time with the consent of both the parties enlarge the time frame for making and publishing the award. Subject to aforesaid arbitration and conciliation Act, 1996 and the rules made there under, any modification thereof for the time being in force shall be deemed to apply to the arbitration proceeding under this clause.
- 8.3 The venue of the arbitration proceeding shall be office of the S.E Civil Dimapur ator such other place as the arbitrator may decide.

9. <u>Set Off</u>

Any sum of money due and payable to the contractor (including security deposit refundable to him) under this contract may be appropriated by BSNL and set off the same against any claim of BSNL for payment of a sum of money arising out of this contract or under any other contract made by contractor with BSNL.

SECTION IV

SPECIAL CONDITIONS OF CONTRACT

- 1. The special conditions of contract shall supplement the instruction to the Bidders as contained in section II and general (commercial) conditions of the contract as contained in section III and wherever there is a conflict, the provisions herein shall prevail over those in section II and section III.
- 2. In case the date fixed for opening of bids is subsequently declared as holiday by the Government of India, the revised schedule will be notified. However, in absence of such notification, the bids will be opened on next working day, time and venue remaining unaltered.
- 3. BSNL reserves the right to disqualify such bidders who have a record of not meeting contractual obligations against earlier contract into with BSNL.
- 4. BSNL reserves the right to blacklist a bidder for a suitable period in case he fails to honour his bid without sufficient ground.
- 5. The liability under relevant sections of Motor Vehicle Act 1968 and IPC causing death or permanent liability developed in the vehicle supplied by the contractor, the hiring authority has no responsibility of whatsoever and will not entertain any in this regard under the provision of the law.
- 6. The engagement and employment of drivers and payment of wages to them as per existing provisions of various labour laws and regulations is the sole responsibility of the contractor and any breach of such laws or regulations shall be deemed to be breach of this contract.
- 7. No sub-contracting is permissible by BSNL. The near relatives of all BSNL employees {non-executive employees working in Dimapur & executive employees (also called Group-A & Group-B officers working in Dimapur either directly recruited or on deputation are prohibited from participation in this tender. The near relatives for this purpose are defined as
 - (a) Members of a Hindu Undivided Family.
 - (b) They are husband and wife,
 - (c) The one is related to the other in the manner as father, mother, son(s), son's wife (daughter-in-law), Daughter(s) & daughter's husband (son-in-law), brother(s) & brother's wife, sister(s) & sister's husband (brother-in-law)
 - 8. The tenderer(s) should give a certificate to the effect that none of his/her such relative is working in the unit of BSNL as defined above. In case of proprietorship firm the certificate will be given by the proprietor, for partnership firm certificate will be given by all the partners and in case of Limited company by all directors of the Company. Any breach of these conditions by the company or firm or any other person, the tender/work will be cancelled and earnest money/security deposit will be forfeited at any stage whenever it is noticed. The BSNL will not pay any damages to the company or firm or concerned person. The company or firm or the person will also be debarred for further participation in the concerned unit.

- 9. The contractor shall assign the job of driving of hired vehicles only to qualified experienced licensed drivers and also assume full responsibility for the safety and security of the officers/officials as well as essential store items while running the vehicle by ensuring safe driving. BSNL shall have no direct or indirect liability arising out of such negligent, rash and impetuous driving which is an offence under section 29 of IPC and any loss caused to BSNL have to be suitably compensated by contractor.
- 10. The contractor shall when called upon to do so, place at the disposal of BSNL such number of vehicles as may be required although the number of vehicles so demanded may be more than the number of vehicles he is required to supply for the purpose of execution of the contract at same rate and terms and conditions. The number of such vehicles to be supplied extra will not be more than 25% of original schedule or requirement in the NIT.
- 11. In no case a vehicle which is not registered for the commercial purpose shall be supplied to BSNL and taxes etc. due on such vehicles shall be liability of the contractor.
- 12. The contractor shall sent the vehicle for periodical servicing at the cost of the contractor, BSNL will not play any mileage run for such servicing nor any deduction be made for the duration involved in such servicing. The cost of lubricants, repairs, maintenance, taxes insurance, etc. will be to the contractor's liability.
- 13. BSNL reserves right to counter offer price against price quoted by the bidder.
- 14. The bidder with the lowest evaluated price will be considered for about 30% of tendered quantity and the balance quantity will be ordered on the remaining selected bidders. However, BSNL reserves the right for placement of full tendered quantity on the lowest bidder.
- 15. Regular checking of meter by the designated transport authority may be done by the contractor and requisite certificate may be shown to BSNL as an when demanded.
