(a) Printed forms of tenders consisting of the detailed plans, complete specifications, the schedule of quantities of the various classes of works to be done and the set of conditions of contract to be complied with by the persons whose tender may be accepted, can be purchased, at the Sub Division office between the hours of 11.00 hrs and 16.00 hrs. Every day except on Sundays and public Holidays on payment of Rs.177.00 in cash/Each.
 - (b) The site for the work is available/ or the site for the works shall be made available in parts.
 - (c) The tender forms can also be downloaded from the website.
 - (d) Before tendering, the contractor shall inspect the site and fully acquaint himself about the condition with regard to accessibility of site and site nature and the extend of grounds, working condition, including stocking of materials, installation of T&P etc., and conditions affecting accommodation and movement of labour etc., required for the satisfactory execution of the contract. No claim whatsoever on such account shall be entertained by the BSNL in any circumstances.
- 03. Tenders which should always be placed in sealed covers with the name of the work written on the envelope will be received by the Sub Divisional Engineer (E), BSNL Electrical Division, Dimapur Upto **15.00** hours on **14/05/2019** and will be opened by him in his office on the same day at **15.30 hours**. - 04. The time allowed for carrying out the work will be as mention above from the 10th day after the date of written order to commence the work.
- **05.** Issue of tender form will be stopped two days before the date fixed for opening of tenders. Tenders will be sold on working days; no tenders will be sold after **16.00 hours**.
- a) Earnest Money as above in the form of demand draft/ FDR/ BG/ CDR of a nationalized/scheduled bank guaranteed by the Reserve Bank of India, drawn in favor of **Accounts Officer (Cash), O/o the GMTD, Nagaland SSA.** must accompany each tender and each tender should be in two sealed covers, one cover containing the EMD in proper form and other cover containing tender, super scribed as "Tender for the work " **The Validity period of EMD is 120 days, from the date of opening of tender**.  - c) Exemption from payment of earnest money and security deposit by any other unit/ department shall not hold good for BSNL.
- 07. a) The contractor should submit and confirm Chartered Accountant Certificate in respect of turnover and other registration certificate [Enlistment in BSNL, Electrical License, Sales Tax] with attested copies (self attested and counter attested by any executive of BSNL/MTNL or Gazetted officer of GOI) as applicable along with the application on printed letter head for purchase of tender.
 - b) The contractor shall submit and confirm his permanent account number (PAN) issued by the Income Tax Department.

- c) The tenderer should submit the valid GST registration certificate
- 08. i) Performance Guarantee: The contractor is required to furnish performance guarantee for an amount equal to 5% of the contract value in the form of bank guarantee / CDR/FDR/DD (of a nationalized/ Scheduled Bank in a standard format) within two weeks from the date of issue of award letter. This period can be further extended by the Engineer-in-charge upto a maximum period of weeks on written request of Contractor. The validity period of the performance security in the form of performance bank guarantee shall be one year from the date of actual completion of work.
 - ii) <u>Security deposit</u>: In addition to performance guarantee stated above, a sum @ 10% of the gross amount of the bill shall be deducted from each running bill of the contractor till the sum be deducted with the sum already deposited as earnest money, will amount to security deposit of 5% of the Tendered value of the work
- **09.** The acceptance of a tender will rest with the Engineer-in-charge who does not bind himself to accept the lowest tender or any other tender and reserves to himself the Authority to reject lowest or all the tenders received without assigning any reason. All tenders in which any of the prescribed conditions are not fulfilled or incomplete in any respect are liable to be rejected. **Tenders with any condition including that of conditional rebates shall be rejected forthwith summarily.**

 - ii) Near relatives of all BSNL employees either directly recruited or on deputation are prohibited from participation in tenders and execution of works in the different units of BSNL. The near relatives for this purpose are defined as:

No employee in BSNL/ Govt. of India is allowed to work as a contractor for a period of two years of his retirement from service without the prior permission. The contract is liable to be cancelled if either the contractor or any of his employees is found at any time to be such a person who had not obtained the permission as aforesaid before submission of tender and engagement in the contractors service.

SCHEDULE "D" (III) IMPORTANT NOTES FOR CONTRACTORS

1. EARNEST MONEY:

1.1 VALUE:

The amount of Earnest Money to be deposited with each tender is 2% of the estimated cost put to the tender *subject to a maximum of Rs. 2 crores.* Earnest money will be acceptable in the form of CDR / FDR / DD / BG.

2. PAYMENT TERMS:

No advance payment will be made. The payment terms shall be governed as per Clause-7 of BSNL-8. No payment will be made for goods rejected at the site. Payment, if made, for such items shall be recovered from subsequent bills or other bills. Stipulations like levy of interest if payment is not made in specified time are not acceptable to the BSNL.

- (a) For claiming this payment the following documents are to be submitted to the paying authority:
- (i) Invoice clearly indicating Service Tax.
- (ii) If the supplier/contractor fails to furnish necessary supporting documents regarding proof of payment of service tax which are Cent -vat able the amount pertaining to such Duties/ taxes will be deducted from the payment due to the firm.

3. BID PRICES:

- (i) The bidder shall give the total composite price inclusive of all levies & taxes i.e. Sales Tax & Excise, packing, forwarding, freight and insurance etc. but excluding Octroi/Entry Tax which will be paid extra as per actual, wherever applicable. The offer shall be firm in Indian Rupees. No Foreign Exchange will be made available by the purchaser.
- (ii) □ Prices indicated in the Price schedule shall be entered as per price schedule given at page nos <u>21-22</u> for all the items given in the "Schedule-A".
- (iii) The contractor/supplier shall submit to BSNL documents/proof of payment of all taxes/ levies along with exemption certificate, if any, to avail CENVAT benefits by BSNL. The invoice favoring BSNL shall be issued by the supplier.
- (iv) A bid submitted with an adjustable price quotation will be treated as non-responsive and rejected.
- (v) The price quoted by the bidder shall be in sufficient detail to enable the Purchaser to arrive at the price of equipment/ system offered.
- (vi) 'DISCOUNT" if any, offered by the bidders shall not be considered unless specifically indicated in the price schedule. Bidders desiring to offer discount shall therefore modify their offers suitably while quoting and shall quote clearly net price taking all such factors like Discount, free supply etc. into account.

(vii) The price approved by BSNL for procurement will be inclusive of levies and taxes, packing, forwarding, freight and insurance as mentioned in clause 3(i) above subject to other terms and conditions as stipulated in clause-4(a) and clause -2 of Bid-document.

4. EVALUATION AND COMPARISON OF SUBSTANTIALLY RESPONSIVE BIDS

- (a) The evaluation and comparison of responsive bids shall be done on the basis of Net cost to BSNL on the prices of the goods offered inclusive of Duties and taxes (but excluding CENVAT-able Duties & Taxes), Sales Tax, Packing, Forwarding, Freight and Insurance charges etc. As stipulated in clause 3.(i), Octroi/Entry Taxes are not to be included in the composite price and hence the same will not be considered for the purpose of evaluation and comparison of responsive bids. However, Octroi/Entry Taxes will be paid extra, as per actual wherever applicable on production of proof of payment/relevant invoices/documents.
- (b) (i) "Duties & Taxes for which the firm has to furnish Cenvatable Challans / Invoices will be indicated separately in the Work Order
- (ii) In case the Duties & Taxes which are non CENVAT-able as per the quotes indicated in the price schedule by the vendors and subsequently at any stage it is found that Credit for such Duties &

Taxes is admissible as per CENVAT Credit Rules, 2004, then the vendors will be liable to refund the amount equivalent to such Duties & Taxes if already paid to them. However, the purchaser may allow the supplier to submit necessary documents in this regard which may enable the purchaser to avail the CENVAT credit provided such credit is still available for the amount so paid as per CENVAT Credit Rules 2004.

- (iii) "If the supplier fails to furnish necessary supporting documents in respect of the Duties/taxes which are Cenvat-able, the amount pertaining to such Duties/Taxes will be deducted from the payment due to the firm."
- **5.** The firm shall read carefully the following conditions and shall quote accordingly confirming all the points in their offer.
- (a) Department reserves the right to accept the quantities in full or in parts.
- (b) Department reserves the right to send authorized representative to witness the test if felt necessary.
- (c) Since the contract period of this work is less than eighteen months therefore Clause **10(CC)** will not be applicable as per section 32.8.2 of CPWD Manual.

6. PROGRAMME FOR EXECUTION:

- (a) The firm shall supply the detailed programme to the Engineer-in-charge within seven days award letter. The programme shall contain details about submission of drawing & tentative dates for inspection/testing by the department.
- (b) The firm shall get layout approved from the Engineer-in-charge. The approval of layout drawings will not absolve the firm from it's responsibilities for supplying and installing the system in accordance with the relevant specifications/ codes/agreement conditions

7. QUALITY ASSÜRANCE:

The EI works shall be executed in accordance to the CPWD specifications. The work is considered to be completed only after the successful completion of Testing of the system as per CPWD specifications and clearance from Electrical Inspector. Responsibility lies with the contractor to get the clearance for construction of HT line and charging of HT line from the Electrical Inspector of the local Electrical Inspectorate / Electricity Authority / Board.

10. SPECIAL CONDITIONS:

- (i) The firm should note that offers with condition and / or conditional rebates will be summarily rejected.
- (ii) The layout of the work will be given by the Engineer-in-Charge or his duly authorized representative at site of works.
- Earthing test, Insulation test, Continuity test. And test report
- (v) Any damage done to the building during the execution of work will have to make good at the entire satisfaction of Engineer-in-Charge.
- (vi) Items which are not included in the "list of approved makes" only ISI marked material shall be used. In case ISI marked is not available in particular item, material conforming to BS, shall be provided.

8. STORES AND MATERIALS:

All the stores and materials required for the work except those specified, as departmental supply shall be arranged at work site by the firm from his own resources or open market. It should be clearly understood that no claim whatsoever should be entertained by the department on this account. Safe custody of the materials brought at site shall be firm's responsibility till the installation is taken over by the department after successful testing & commissioning. However a lockable space may be provided by the department on intimation well in advance before receipt of material at site. Accommodation for erection crew will not be provided by the department.

9. CO-ORDINATION:

Generally more than one agency is working at the same premises. It shall be the aim of agencies that on their account the work of the other agencies is not delayed. Full co-ordination and co-operation shall therefore be extended during the execution of the work to ensure prompt and quality work.

TAXES & DUTIES

1

GST INVOICE & COMPLIANCES

- 1.1 All the details of supplier (name, address, GSTIN/ unregistered supplier, place of supply, SAC/ HSN code etc.) and other mandatory details shall be mentioned on the invoice.
- 1.2 Invoice/Supplementary invoice/Debit Note/Credit Note/Receipt Voucher need to be issued in compliant format and timely within the time prescribed under GST law.
- 1.3 In case of any deficient/incomplete/rejected supply, BSNL shall convey the same in a reasonable time to enable the supplier to issue credit note and take tax adjustment.
- 1.4 It would be the responsibility of the supplier to declare correct information on invoice and GSTN viz. the amount, the place of supply, rate of tax etc. In case, the eligibility of input tax credit is questioned or denied to BSNL on account of default by the supplier, the same would be recovered by BSNL from the supplier.
- 1.5. Registered location of the both the parties i.e. BSNL and supplier should be mentioned in the agreement with GSTIN No. Further, supplier should raise invoices at the registered premise of BSNL for availing of credit and ensure that the place of supply as per GST law is same as registered premise
- 1.6. BSNL could at any time instruct the supplier to raise its invoices at a particular location of BSNL
- 1.7. It is the responsibility of the supplier to ensure that place of supply and the GSTN of BSNL are in the same state. If for any reason they are not in the same state, the supplier shall intimate to BSNL and give adequate time before raising of the invoice.
- 1.8. E-waybill number should be mentioned on the invoices.
- 1.9. Supplier shall be responsibile for timely issuance and delivery of invoice/ DN/ CN to enable BSNL to claim tax benefit on or before the stipulated time period provided by the GST law.
- (a) It is the responsibility of the supplier to ensure that outward supply return (GSTR-1) would be filed correctly. If not, than cost would be borne by supplier.
- (b) Reporting of correct outward supply by supplier in the outward return (GSTR-1) is the responsibility of the supplier. In case of mismatch because of supplier's fault, prompt amendments must be made by the supplier else supplier would be required to indemnify BSNL of the loss of credit due to mis-match. The compliances to be adhered by supplier includes (but is not limited to) the following:
- (i) Uploading appropriate invoice details on the GSTN within the stipulated time;
- (ii) Issuing GST compliant invoice / CN/ DN. PO issued by BSNL should be referred by supplier for capturing information on the invoice.
- (iii) Supplier needs to pay the entire self-assessed tax on timely basis.
- (iv) Where invoice is not uploaded or incorrect upload of invoice detail of GSTN by supplier then credit on such invoice will be given provisionally subject to matching. So, acceptance of changes made by BSNL on GSTN on account of non-upload or incorrect upload of invoice details on GSTN is to be submitted by supplier. - 1. The work shall be done as per current CPWD specifications, electrical works as embedded from time to time and Indian Electricity rules as amended up to date.
- 2. The work shall be supervised by qualified technical staff.
- 3. The layout of the work will be given by the Engineer-in charge or his duly authorized representative at site of work.
- 4. The following works shall be done on separate conduits
- a) Power plug wiring.
- b) Light and fan point wiring.
- c) Emergency light point wiring. (AC supply/DC supply)
- d) Telephone wiring.
- e) Clock wiring.
- f) AC units wiring.

The number of power plug points and emergency light points fed from the DC supply shall not exceed to per circuit in any of the cases.

- 5. The earthing sets shall be provided in the presence of Engineer-in-charge or his authorized representative.
- 6. Sample of all the materials, fittings, accessories, IC switch gears, etc. Shall be got approved from the Engineer-in charge before using the name on the work. The rejected materials shall be removed immediately from the site of work.
- 7. The contractor shall have to submit the completion plan as clause 6(A)1,6(B) of the agreement within 30days of the completion of works. Failing to submit the completion plan, he will be liable to pay a sum equivalent 2.5% of the value of work subject to a ceiling of Rs.2,500/- as per the clause 6(A)1,6(B) of the agreement.
- 8. The contractor will have to give the following tests at his cost and intimate test results before final bills are paid. Nothing extra will be paid on this account. a) Earth test. B) Polarity Test. C) Insulation Test. d) Extra continuity test of the surface/recess conduit pipes.
- 9. Any damage done to the building by the contractor during the execution of work shall have to be made good at his cost and risk. If he does not do it himself within a reasonable time (determined by the Executive Engineer (E) then same will be got done at his cost departmental after giving notice to him.
- 10. The outlet boxes I.C boxes for switches and end of conduits etc. for different categories of conduit runs catering for different types of electrical wiring as mentioned in clause above shall be painted 8inside/outside with different colour each signifying the decrement categories mentioned so as to avoid mixing of various circuits and their wiring and nothing extra will be paid for this.
- 11. In the time laying conduit pipe in the slab and in recess, the contractor will keep fish wire of 16 SWG GI wire through out conduit pipe and will have to take special care so that the conduits do not pass through air-conditioning ducts, grills columns, if any such necessity is foreseen special written permission of E.E.(E) will be obtained before such works is carries out. In case of failure, the contractor will not be paid on this account.

The successful tendered should reason the conduit in the wells before they are plastered and in collaboration with building work in progress. Any damage thus done will have to be made good at the cost electrically continuous.

12. The bakelite covers for the tumbler switches plug sockets etc shall be removed or broken for taking connections which shall be done at their back be providing suitable wooden rider in the I.C. boxes where found necessary. All I.C boxes for switches, plug and regulators etc. Shall be provided 1/8" thick bakelite sheet covers.

- 13. The runs of various circuit wiring at various places shall kept minimum by taking the runs on wall where crossing of columns is not necessary. This has to be decided before casting of slab so that unnecessary length of conduits are not laid therein.
- 14. All the I.C. distribution board, Sub-main board and their complete fitting shall be sign-written clearly indicating the No of distribution board, the type of load it is serving and the number of circuit contained in the distribution box shall be placed in a tabular form the reverse of the cover of the distribution box.
- 15. Underground cables both of 1.1KV and 1.1KV grade should be subjected to pressure/insulation tests before and after laying the same in the ducts. Incase of unsatisfactory test the cost of all replacement and extra work of removal and relaying well have to be made good by the contractor at his own risk.
- 16. While make the end connections of wires, no strand shall be cut and the termination of wires shall be done with necessary lugs and ferrules without any extra payment.
- 17. The bus bars of the single phase distributions box shall be strip instead of sheet metal.
- 18. The lugs should be provided while terminating 8 SWG G.I wire for earth continuity without any extra payment.
- 19. The contractor will have to make arrangement to take the material to site of work at his own risk. Octori, if paid by the contractor for the materials supplied by the department the same can be claimed by him against original voucher.
- 20. If any conduits laid before the award of this work, the recovery for the same will be made from the contractor at the rates specifications in the SR-94(internal) plus the enhancement of this tender. Or the rates quoted by the firm in the tender for the work.
- 21. The Department shall not supply any tools and plants unless otherwise specified.

NOTE: In addition to above the work should be carried out as per latest CPWD/ BSNL specification pertaining to the work, ammended up to date and as per the direction of the Engineer - In - Charge.
