However, if required, authorized representatives of bidders can attend at the O/o the Executive Engineer (E), BSNL Electrical Division, Dimapur, where BSNL's Tender Opening Officers would be conducting Public Online Tender Opening Event (TOE).

The tender submitted shall become invalid and tender cost shall not be refunded if:

- i) The tenderer is found ineligible.

(For viewing only) Deviation if any in Technical specifications / Commercial Terms & Conditions of DNIT will be given by the firm on its letter head duly signed & same shall be uploaded. In the absence of such letter it will be assumed that there are no deviations.

- **3.** a) The site for the work shall be made available in part. Agreement for work shall be framed by the concerned Executive Engineer [E]. In case agency fails to start the work Performance Guarantee for the awarded amount shall be forfeited.
 - b) Before e-tendering, the contractor shall inspect the site and fully acquaint himself about the condition with regard to accessibility of site and site nature and the extend of grounds, working condition, including stocking of materials, installation of T&P etc., and conditions affecting accommodation and movement of labour etc., required for the satisfactory execution of the contract. No claim whatsoever on such account shall be entertained by the BSNL in any circumstances.
- 4. Agreement shall be drawn with the successful Tenderer on prescribed Form No. BSNL EW6 & 8, which is available in the **O/o Executive Engineer (E), BSNL Electrical Division, Dimapur**. Tenderer shall quote his rates as per various terms and conditions of the said form.
- 5. The time allowed for carrying out the work will be as mentioned in the above table.
- **6.** a) The EMD of all the unsuccessful tenderer shall be released on issue of award letter to the successful tenderer. This shall be done within one week of award letter.
- b) Exemption from payment of earnest money and security deposit by any other unit/ department shall not hold good for BSNL.

7. In case the eligibility credentials are not found in order at any stage i.e. before award of work or during execution of the work or after completion of the work, the contractor will be liable to debar from tendering in BSNL for the period as decided by competent authority including any other action under the contract or existing law.

8. Performance Guarantee & Security Deposit

a) Performance Guarantee (PG):- The Firm shall have to furnish Performance guarantee @ 5% of the contract value of the Master Agreement (contract) within two weeks of the issue of commencement letter in the form of Bank guarantee on a Nationalized/Scheduled bank in standard format (Annexure B)/ CDR/ FDR/ DD. This performance guarantee shall be submitted in the Electrical Division in the name of concerned Accounts Officer and shall be valid for One Year from the date of stipulated date of completion. In the event of failure on the part of successful tenderer to furnish the performance guarantee within fifteen days, the EMD will be forfeited and tender shall be cancelled.

b) <u>Security deposit</u>: In addition to the Performance Guarantee stated above a sum of @ 10% of the gross amount of the bill shall be deducted from each running bill of the contractor till the sum be deducted with the sum already deposited as earnest money, will amount to security deposit of 5% of the tendered value of the work. This Security Deposit shall be released after an observation period of 12 months after the date of completion of work.

9. The acceptance of a tender will rest with the Executive Engineer (E), Dimapur, who does not bind himself to accept the lowest tender or any other tender and reserves to himself the Authority to reject lowest or all the tenders received without assigning any reason. All tenders in which any of the prescribed conditions are not fulfilled or incomplete in any respect are liable to be rejected.

10. Canvassing in connection with tender is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable for rejection.

11. The BSNL reserves itself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rates quoted.

12. i) The tenderer should give a certificate that none of his/her relative is employed in BSNL units. In case of proprietorship firm, certificate will be given by the proprietor and for partnership firm certificate will be given by all the Directors of the company.

- ii) Near relatives of all BSNL employees either directly recruited or on deputation are prohibited from participation in tenders and execution of works in the different units of BSNL. The near relatives for this purpose are defined as:
 - a) Members of a Hindu Undivided family.
- b) They are husband and wife.
- c) The one is related to the other in the manner as father, mother, son(s) & son's wife (daughterin-law), Daughter(s) & daughter's husband (son-in-law), brother(s) & brother's wife, sister(s) & sister's husband (brother -in-law).
- iii) The company or firm or any other person is not permitted to tender for works in BSNL Unit in which his near relative(s) is (are) posted. The unit is defined as SSA/Circle/Chief Engineer/Chief Archt./Corporate office for non executive employees and all SSA in a circle including circle office/Chief Eng./Chief Archt./Corporate office for executive employees (including those called as Gazetted officers at present). The tenderer should give a certificate that none of his/her such near relative is working in the units as defined above where he is going to apply for tender/work, for proprietorship, partnership firms and limited company certificate shall be given by the authorized signatory of the firm. Any breach of these conditions by the company or firm or any other person, the tender/work will be cancelled and earnest money/performance guarantee will be forfeited at any stage whenever it is so noticed. BSNL will not pay any damages to the company or firm or the concerned person. The company or firm or the person will also be debarred for further participation in the concerned unit. The format of the certificate to be given is prescribed on Page No. 17.

13 No employee in BSNL/ Govt. of India is allowed to work as a contractor for a period of two years of his retirement from service without the prior permission. The contract is liable to be cancelled if either the contractor or any of his employees is found at any time to be such a person who had not obtained the permission as aforesaid before submission of tender and engagement in the contractor's service.

14. The tender for the works shall not be witnessed by the contractor who himself/themselves has/ have tendered or who may and has/have tenderfor the same work. Failure to observe this condition would render tenders of the contractors tendering as witnessing the tender is/are liable for summarily rejection.

15. The tenders for the work shall remain open for acceptance for a period of <u>90 days</u> from the date of opening of the tenders. If any tenderer withdraws his tender before the said period or makes any modification in the terms and conditions of the tender which is not acceptable to the BSNL shall, without prejudice to any other right of remedy be at liberty to forfeit 50% (fifty percent only) of the said earnest moneyabsolutely.

16. <u>Extension of validity:</u> In case, where the letter of award of work cannot be placed within the

validity period of the tender, the BSNL can request all tenderers to extend the validity of their respective tenders and the Earnest Money deposit by a reasonable period. In such cases, extension of validity of Earnest Money deposit by 30 days beyond the extended validity date of tender should also be asked for. While BSNL can make the request for extension, the tenderer is free to either extend the validity or refuse the request to extend the validity.

17. The contractor should read the tender documents carefully before submitting the tender.

18. This Notice Inviting Tender shall form part of the Contract document. The successful tenderer/contractor on acceptance of his tender by the Accepting authority, shall, within 15 days from the stipulated date of start of the work, sign the contract consisting of:-a)The Notice Inviting Tender, all the documents including additional conditions, specifications and drawings, if any, forming the tender as issued at the time of invitation of tender and acceptance thereof together with any correspondence leading thereto.

19. If any terms and conditions mentioned from P-1 to P-38 are in contravention to General Conditions of Contract 2010, the terms and conditions mentioned from P-1 to P-38 shall prevail.

- 3. The intending bidder must have valid Class-III digital signature to submit the bid.
- 4. The intending bidder should read carefully and understand the tender document, procedure for e- tendering etc. completely before participating in the e-tender procedure. Participation in the e-tendering, presumes that the bidder (s) has/have read all the conditions, Special Conditions of the contract, Schedule of quantity etc. and agree/abide by them. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- 5. INSTRUCTIONS FOR IMPLEMENTATION OF GST:

1. The rates quoted must be full & final. Nothing extra is payable other than the quoted rates.

GST shall be paid extra as applicable as indicated in the 'Schedule of Work' (BOQ)

The Evaluation & Comparison of bids shall be done on the basis of **NET COST TO BSNL** on the prices of the Goods / Services offered along with all applicable Taxes, Packing, Forwarding, Freight & Insurance charges etc as arrived in "Schedule of Work" of the Bid document but excluding GST which is creditable to BSNL. If GST is not quoted separately same shall be treated as NIL and no payment shall be done on account of GST. The tender will be decided on the basis of quoted Basic Cost.

2. Necessary declaration, statutory forms (if any) shall be provided by BSNL to avail concessional rate of tax wherever applicable on the request of the bidder as & when asked for.

After physical completion of the installation following testing shall be conducted by the firm in the presence of Engineer-in-charge or any representative of the department at his cost & intimate test results before commissioning .. Nothing extra will be paid to him on this account.

- **a** Megger test between Phases, Neutral and Earth for all systems.
- **b** Earth Resistance test for all earth stations.
- c Functional test of all switchgears and circuit breakers.
- **d** Relay test & their settings.
- e Polarity test.

(a) The BSNL shall have the right to operate all equipments if in operating conditions, whether or not such equipment, have been accepted as complete and satisfactory. Repairs and alternations shall be made at such times as directed by Engineer-in-Charge.

(b) In special circumstances the BSNL may have to use the equipment even before the completion of whole work. The firm shall co-operate fully under such circumstances.

(c) Wherever relaxations are required, these should be obtained from the Superintending Engineer (Electrical) well before the final performance test.

(d) All test equipments, the operating personnel, required for testing shall be supplied by the contractor.

(e) At the final inspection a factory trained representative of the manufacturer of the major equipment shall demonstrate that the system is functioning properly in every respect.

(f) The contractor shall provide all necessary facilities for inspection of his equipment. In case of imported equipments, the contractor shall furnish the routine and type test certificates to the satisfaction of Engineer-in- charge.

(g) All information, documents and tests as required by BSNL for their final approval for this installation shall have to be arranged by the contractor.

17. REJECTION OF DEFECTIVE INSTALLATION:

The reject material will be cleared from site immediately on rejection. If the complete system or

any part thereof, before it is taken over, be found defective or fails to fulfill the intent of the specification, the contractor, shall, on receipt of a written notice from the Engineer-in-charge forthwith made good the defects, should the contractor fail to rectify the defects and or make good the defective system within a stipulated time mentioned in the written notice or replace the equipment's / components at no extra cost, department may make good, reject or replace the same at the risk and expenses of the contractors, the whole or any portion of the system which is defective or fails to fulfill the requirements of the contract.

Compensation to be levied in cases of use of duplicate/ spurious material.

- 1. Department reserves the right to get inspected any components thereof by the manufacturer / their authorized representative, whose report as regards to the genuineness of component shall be final and binding. In case any component upon such inspection is found to be duplicate/spurious, double the cost of such component based on price list (without any discount whatsoever) effective on date of aforesaid inspection shall be recoverable.
- 2. In case the contractor agrees to replace the components so found spurious/duplicate at his cost, within 15 days of the said report compensation of Rs. 3,000/- per component found spurious/duplicate should be levied against the contractor.
- 3. Besides the above the department reserves the right to take disciplinary action against the Contractor.
- 4. Decision of Superintending Engineer (E), Dimapur in such case shall be final.

18. GENERAL CONDITIONS:-

The following general conditions of Contract are deemed to have been agreed upon.

- 1. All civil works such as construction of foundation for the equipments with masonry or the steel members as may be required is included in the scope of work.
- 2. Any damage or breakage, which might be caused during the execution of work, shall be made good by the contractor at his own risk and cost.
- 3. The contractor is responsible for the removal of debris and waste materials arising out of the work done by him, from the site.
- 4. Necessary tools and plants shall be arranged by the firm. Modern tools and equipment shall be need for handling of cables and machines, drilling, chiseling, cutting etc. So that speed, accuracy, minimum noise, vibrations and disturbance to the building/occupants / equipment's can be achieved.
- 5. The firm shall provide necessary barriers, warnings, signals and other safety measures to avoid any accident. The employees of the firm are to be suitably insured against such accidents. The dept. shall not be responsible for any such accidents.
- 6. The concealed items like earthing, cabling, conduiting etc. shall be carried out only in presence of duly authorized department staff.
- 7. The offer shall include all changes for packing, handling, freight, insurance, loading, unloading, stocking etc. for the material.
- 8. Work shall generally be carried out during working hours. However as per the department requirement the working hours shall be extended without any extra claim.
- 9. All fittings unit assemblies, accessories, hardware foundation bolts, terminal blocks for connections, cable glands and miscellaneous material and accessories of items of work which are useful and necessary for efficient assembly within the scope equipment shall be deemed to have been included within the scope of work in the tender and within the overall details for complete item whether they have been specifically mentioned or not.
- 19. Bye-laws Indemnity against Liabilities
 - 1. The contractor shall comply with all bye-laws and regulations of local and statutory

authorities having jurisdiction over the works and shall be responsible for payment of all fee and other charges and giving/receiving all necessary notices and keep the Engineer-in-Charge informed about the notices issued and received.

- 2. The contractor shall indemnify BSNL against all claims in respect of patent rights, design, trade mark or name of other protected rights in respect of any plant, machine, work or materials used for or in connection with the works or temporary works and from and against all claims, demands, proceedings, costs, charges and expenses whatsoever in respect of or in relation thereon. The contractor shall defend all actions arising from such claims and shall himself pay all royalties.
- 3. License fees, damages, cost and charges of all and every sort that may be legally incurred in respect thereof shall be borne by the contractor.
- 4. All liabilities / penal recoveries on matters arising out of tax/excise/levies such as incorrect deductions, discrepancies in the filling up returns, revised assessments by the concerned authorities etc. shall be borne by the contractor.

It is contractor's liability to follow all safety procedures in accordance with relevant I.S. amended up to date during execution of work at site.

SPECIAL CONDITION

SECTION I: GENERAL SPECIFICATION OF WORKS

SECTION - I GENERAL SPECIFICATIONS

- 1. The work shall be done as per current departmental specification for electrical works as amended from time to time and Indian electricity rules as amended up to date.
- 2. The work shall be supervised by a qualified Supervisor.
- 3. The layout of the work will be given by the Engineer-in-charge or his duly authorized representative at site of work.
- 4. Unapproved materials if brought to site of work shall have to be removed immediately by Contractor at his cost and risk.
- 5. The contractor shall submit the completion plan as per Clause 8.3, of the agreement within 30 days of the completion of work. Failing to submit the completion plan, he will be liable to pay a sum equivalent to 2.5% of the value of work subjected to the ceiling of Rs.15000/- as per the clause-8.3 of agreement.
- 6. The contractor will have to give the following tests at his cost and intimate test results before final bills are paid. Nothing extra will be paid to him on this account.
 - a) Earth test.
 - b) Polarity test.

- 7. Any damage done to the building by the contractor during the execution of work shall have to be made good at his cost and risk. If he does not do it himself within a reasonable time as determine by the Executive Engineer (E) then the same will be got at his cost departmentally after giving notice to him.

SPECIFICATIONS FOR ADDRESSABLE FIRE ALARM SYSTEM

1. INTELIGENT/ANALOG ADDRESSABLE FIRE ALARM SYSTEM 1.1.0 SCOPE OF WORK

1.1.1 The scope of work shall include designing supplying and installing testing and commissioning

of Analogue Addressable Fire Detection cum Alarm System. This shall conform to relevant latest standards for fire alarm systems.

1.1.2 All wiring shall be done using 2 core x 1.5 sqmm PVC insulated armoured copper cable.

1.1.3 OEM of the system should be approved by UL/FM/EN54/VDS/ LPCB.

1.2.0 FIRE ALARM CONTROL PANEL (FACP)

1.2.1 This is a microprocessor-based panel which shall be connected to the various detectors/devices by means of 2 wire loops.

1.2.2 The Fire alarm control panel shall be able to supervise individual detectors for proper

performance as well as to give pinpoint location of fire alarm.

1.2.3 The panel shall have hooter alarm.

1.2.4 The panel shall also have the provision through volt-free contact to activate an auxiliary device in case of fire. i.e. auto dialer for automatically dialing select phone numbers in case of fire.

1.2.5 Loop

a. A loop shall mean a 2-wire circuit connecting minimum 127 addressable detectors and addressable modules

b. The loop card shall have built-in circuit isolator to accommodate Class 'A' wiring.

1.2.6 Addressable Devices

This term indicates the complete group of addressable devices such as detectors, Manual call

Stations, addressable output/input modules etc.

1.2.7 Detectors

a. The Detector shall be intelligent/analog addressable type.

b. The chamber should be easily removable for the purpose of easy maintenance.

c. The address programming shall be done by a Hand held programmer or Base/detector or from the Fire alarm control panel.

d. The detectors shall have a common base to allow easy interchange of various types of detectors.

1.2.8 Manual Call Station

- a. The Manual Call Station shall be addressable type with input modules to define the device/location.
- b. The Manual call station shall be pull type resettable with suitable protection and base box.

1.2.9 Input Module

- a. The input modules shall be of /single point type.
- b. The dual channel module shall be selectable for Normally Open or closed.

1.2.10 Fault Isolator

- a. This unit shall be placed on the loop preferably between devices and shall be able to isolate electrical short circuit in the wiring.
- b. All the other detectors shall remain functional because of the Class A wiring of the loop.
- c. The isolator shall not utilize an address and shall be built into the detector base wherever required.

1.2.11 Sounders

- a. The sounders shall be of addressable type/connected by addressable module/ panel.
- b. The sounders shall derive power from separate cable with voltage adopter/panel.
- c. It shall be capable of being directly mounted on the wall/ceiling or along with the detector.
- d. The sounder shall have an output of at least 85db at 1mtr. The sounder shall be programmed to get activated in event of an alarm from a single detector/device or a group of detectors/ devices.

1.3.0 FIRE ALARM SYSTEM

- 1.3.1 The Fire Alarm System shall give Audio/Visual Alarm Signals when the temperature in case of Heat Detector or smoke density exceeds the pre-set limit.
- 1.3.2 The system shall give pinpoint location of fire with warning system.
- 1.3.3 If the system is with PA & command control centre then the voice communication for

commands and instruction shall be given to PA system console.

- 1.3.4 The system shall have a microprocessor-based control and monitoring facility.
- 1.3.5 It shall be possible to program each loop with up to minimum 127 addressable detectors and addressable modules.
- 1.3.6 Annunciation facility shall also be inbuilt into the Fire alarm control panel, the panel being able to initiate alarm signal for any particular zone.
- 1.3.7 The system shall be fully supervised for all fault conditions with distinctive alarm operated for fault and fire conditions.
- 1.3.8 Test buttons and software features shall be provided to test the electronic circuits and detector health.
- 1.3.9 In case of Fire in an area handled by Fire suppression system the Fire alarm control panel shall be able to actuate fire suppression system
- 1.3.10 The system shall be based on an open protocol to ensure flexibility.

1.4.0 FIRE ALARM CONTROL PANEL

- 1.4.1 The Fire Alarm Control Panel shall be micro processor based fully Analogue Addressable, Analogue Control Unit with centralized monitoring which shall control all Analogue Addressable Detectors, Manual Call Stations and Switching Systems (for actuating Fire suppression system)
- 1.4.2 All addressable units shall be connected to the Fire alarm control panel through the Loop Cards and shall be addressed through individual numbers.

The Fire alarm control panel shall be able to obtain analogue value for all detectors in the circuit through a pulsed digitalized current data. The Fire alarm control panel shall be able to analyses all analogue inputs from all addressable units, and through its own software and ambient level screening the Fire alarm control panel shall be able to identify fire, possible fire or fault conditions.

- 1.4.3 The unit supervision shall be dynamic and continuous.
- 1.4.4 The Fire alarm control panel shall also give adequate warning signal whenever there is dust accumulation in detectors.

It should be possible to change the level of ambient alarm calibration condition by the use of software program.

- 1.4.5 Short / Open circuit fault shall also be reported at the Fire alarm control panel. In such cases, the system through the use of fault isolators shall be able to isolate that segment. The missing Detectors/Devices shall also be reported at the Fire alarm control panel with identification of the location.
- 1.4.6 The Fire alarm control panel shall have the facility to set each smoke sensor sensitivity. It shall also be possible to set the sensitivity to a high level or low level based on night or day time.(time based sensing)
- 1.4.7 When an alarm condition is sensed at the Fire alarm control panel from a smoke or heat detector, a delay time/alarm verification period shall be started. If the sensor is still in alarm after the delay time expires, an alarm condition is reported. The delay time shall be adjustable from 0 to 990 sec's.
- 1.4.8 The Fire alarm control panel shall have the facility to perform walk test.
- 1.4.9 In the walk test mode, the performance of each device is checked out by initiating the device.
- 1.4.10 As each device is placed into alarm the Fire alarm control panel shall print the condition and automatically reset the device.
- 1.4.11 Audible devices shall be initiated, if required at a pre-programmed time.
- 1.4.12 If a zone is inadvertently left in walk test mode, it shall automatically reset to normal after the idle time is exceeded.
- 1.4.13 During the walk test the zones other than the programmed zones shall be under continuous supervision (normal mode).
- 1.4.14 In case of any alarm initiated by detector/devices the walk test shall get terminated automatically.
- 1.4.15 Programming functions shall include alarm/trouble type assignment, point descriptor assignment, alarm message assignment, etc.
- 1.4.16 Programming shall be carried out from the Fire alarm control panel keyboard or utilizing the authorized laptop/desktop computer software.

Contractor

1.4.17 The Fire alarm control panel shall have a Liquid Crystal Display of Alphanumeric type.

- 1.4.18 In case of testing of the system from the Fire alarm control panel the Display shall be able to give readouts of analogue value of all detectors being tested.
- 1.4.19 The Fire alarm control panel shall also be able to carry out continuous self monitoring when in normal condition.
- 1.4.20 The Fire alarm control panel shall have provision to add either an in-built or external printer coupled to the Fire alarm control panel, which shall log all events with time.
- 1.4.21 The printout shall clearly indicate the event Fire/Pre Alarm/Fault etc. With the unit address and time.
- 1.4.22 The Fire alarm control panel shall also be able to discriminate between false alarms and fire conditions.
- 1.4.23 The Fire alarm control panel shall carry out priority selection of alarm in case alarm activities in two or more remotely located units simultaneously. In such cases, the manual call stations shall have the highest priority.
- 1.4.24 The System shall be failure safe and adequate safe guards should be ensured that in the event of a failure of a part of the System it shall not handicap the complete System.
- 1.4.25 The agency shall be responsible for preparation and installation of System Software into the Fire Alarm Control Panel.
- 1.4.26 The Software shall be user friendly.
- 1.4.27 The system shall be secured against Software errors.
- 1.4.28 The system shall have the ability to be upgraded so as to incorporate more features at a later date.
- 1.4.29 The Fire alarm control panel shall have its own Battery Backup of a minimum of 24 hours in normal run and then half an hour in alarm condition.
- 1.4.30 The voltage rating shall be from 14V DC to 31V DC, though the voltage may be change.
- 1.4.31 The Fire alarm control panel shall be totally enclosed dust and vermin proof type made of minimum 13 gauge dust inhibited sheet with even baked finish. The Fire alarm control panel shall be of completely solid state design.

- 1.4.32 The Fire alarm control panel shall have UL/FM/EN54/VDS/ LPCB approval.
- 1.4.33 The Fire alarm control panel shall have provision for interfacing with the Public Address System & auto dialer. Fire alarm control panel shall be able to call four telephone numbers per channel.

1.5.0 ADDRESSABLE DETECTORS

A. Multi sensor Detector

- 1.5.1 All detectors shall be fitted with plug-in system type, from the maintenance and compatibility point of views. An alarm condition should not affect a detector's good functioning. After resetting the alarm, the detector shall resume operations without readjustment of any kind.
- 1.5.2 The detector shall have a Multi-sensor type integrates photoelectric smoke and fixed temperature heat sensing technology. It shall be possible to use a single detector type for both above and below false ceiling applications. The detector shall be capable of detecting fast flaming fires and slow smoldering fires equally well. The detector shall therefore be a multi technology detector.
- 1.5.3 The detector shall be able to sense incipient fire by detecting the presence of visible and invisible products of combustion. The detector shall be suitable for low voltage two wire supply. The detector shall be provided with Twin LED indication.

The sensitivity of the detector shall not vary with change in ambient temperature, humidity, pressure or voltage variation, air currents and should not trigger the false alarm due to the above condition.

- 1.5.4 The detector shall be suitably protected against dust accumulation/ ingress. The detector shall be free from maintenance and functionally tested at periodic intervals. All detectors shall be identical in construction design and characteristic to facilitate easy replacement and interchangeable by suitable programming.
- 1.5.5 The coverage per smoke detector shall strictly follow relevant standards. It shall be possible to connect Smoke Detector with Heat Detector or Manual Push Button in the

same circuit. The sensitivity of detector shall be set from the Fire alarm control panel to suit the site requirement.

1.6.0 MANUAL CALL STATIONS (MCP)

- 1.6.1 The Manual call station shall be pull type with suitable protection and base box. The device shall be red in colour and suitable for surface or flush mounting. Manual stations shall be interface able to an addressable input module. The manual station shall have normally open fire alarm and enunciator contacts and these contacts shall close on activation. Contacts shall remain closed until station is manually reset.
- 1.6.2 The Manual Call Station shall be fully addressable with its own addressable module and operated by digitized signals from the FACP.

1.7.0 SOUNDER

- 1.7.1 The sounder shall be conventional/addressable electronic type with addressable module and shall give discontinuous/Intermittent audible alarm whenever any detector or call box operates.
- 1.7.2 The sounder shall be powered from Main Fire alarm control panel through loop / Separate2 wire cable.

1.8.0 RESPONSE INDICATOR (RI)

- 1.8.1 Whenever detectors are located above false ceiling (On real ceiling) or below false flooring, response indicators(RI) shall be provided for quick identification of the fire location and for convenient testing of the detector and shall have protection against reverse polarity and voltage surges.
- 1.8.2 Response indicators shall be installed with top at 300mm above false floor for detectors in false floor and on the false ceiling for detector above false ceiling near to the location of detectors. RI should be installed in a suitable location which is normally visible.

1.9.0 FIRE ALARM SYSTEM TESTING

- 1.9.1 Fire Alarm Control Panel
- a. The FACP shall be visually checked for input voltage and ampere. All zones one by one shall be

de wired to check for fault signal indication in the FACP.

- b. The Power Source shall be cut off and checked for stand by Supply from the Batteries. After four hours the FACP Source shall be switched on to check for auto switch over to the Mains mode.
- c. Tests shall be conducted for AC fail, charger fail, DC fail, Battery Disconnect or Battery fail. In all such cases the relevant LED should glow and the piezo sound shall also give sound output.
- d. Low battery indication, fault indication should be made available at the panel.

1.9.2 Smoke Detector

- a. The testing shall be carried out for each loop / zone.
- b. Initially one detector in a zone and subsequently 2 or more disassociated detectors in each zone shall be tested for Alarm Priority, Alarm Queuing and Call Logging with time lapse between detectors.
- c. An identified detector shall be subject to smoke aspiration from burning paper/cigarette puffs, rubber and other materials which give dense smoke held at 0.3 M distance from the detector.
- d. The FACP should indicate increased analogue output for that address and after the programmed delay time, a fire alarm signal shall be indicated. This delay shall be utilized for alarm verification.

1.9.3 Combined Test

a. The combined test shall be in combination of Photoelectric / Heat Detectors simultaneously with time lapse between application of smoke or heat or as Additional Test

1.9.4 Additional Test

- a. One detector of each type will be disconnected and subjected to slow dust build up by means as desired by the Consultant/client and again connected in the circuit.
- b. Any part of the Loop shall be short circuited. The FACP shall indicate the communication failure of all the devices connected in the short circuited segment.
- c. After the short circuit is corrected, the Fault Isolator shall return to its normal status automatically, this being reflected in the FACP.

The Loop shall then be in normal operation again. Any part of the Loop shall be de wired and tested as given above for open fault.

1.9.5 All other tests as required by the client at the time of handing over shall also to be conducted.

1.9.6 All fire alarm system i.e Addressable panel, Smoke detector, Hooter, Manual call point should be of same make. Master and slave actuator also be of same make.

SPECIAL CONDITIONS OF CONTRACT

1) <u>GENERAL</u>

The following special conditions shall be read in conjunction with general conditions of contracts and amendments thereto. If there are any provisions in these special conditions which are in variance with the provisions in the other documents, the provisions in these special conditions shall take procedure. The work shall generally be carried out as per IE rules & National building/Electrical code/Fire manuals/BSNL & CPWD specifications & NIT conditions. Department reserves the right to award the work in full or in parts to different agency.

2) INSPECTION OF SITE AND CONTRACT DOCUMENTS

For the purpose of inspection of site and relevant contract the contractor is required to contact the Executive Engineer concerned who shall give reasonable facilities for inspection of the same. The contractor shall inspect and examine the site and shall satisfy himself, before submission of his tender as to the form and nature of site, the quantities and nature of work, materials necessary for completion of work and shall himself obtain all necessary information as to risks, contingencies and circumstances which may influence or affect his tender. No extra charges consequent to any misunderstanding or otherwise shall be allowed.

3) SUFFICIENCY OF TENDER

The contractor shall be deemed to have satisfied himself before entering into the contract as to the correctness and sufficiency of his offer, the work and of the rates quoted in the schedule of works. These rates and amounts shall, except as otherwise provided, cover all his obligations under the contract and all matters and things necessary for proper completion and maintenance and guarantee of the work.

4) STORES AND MATERIALS

All the stores and materials required for the satisfactory completion of work except those specified as departmental supply shall be arranged at work site by the contractor from his own resources or open market. It should be clearly understood that no claim whatsoever shall be entertained by the department on this account. Safe custody of the material brought and installed at site shall be contractor's responsibility till the installation is taken over by the department after successful, performance and acceptance testing. List of approved materials are furnished. In case the firm desires to offer a material not in list, prior permission in writing is to be obtained from Engineer-in-charge.

5) PROGRAMME FOR EXECUTION

Within 15 days from the date of award of the work the contractor shall submit his programme for submission of drawings, supply of equipment, installation, testing and commissioning of the smoke detector system.

The programme shall be framed keeping in view the priorities of areas which might be needed to be covered in the first instant.

6) APPROVAL OF DRAWING

a) The contractor shall get the following drawings approved before start of the work.

i) Floor plans showing location of detectors indicating the proposed distances between the detectors.

- ii) Floor plans indicating the locations of main control panel, local control panels, hooters, manual call points, response indicators etc.
- iii) Conduit/cable layout diagrams clearly indicating details of detectors and other devices connected in a particular zone.
- iv) Drawing showing general arrangement of main control panel and local control panels.
- b) The approval of drawings by the department shall not absolve the firm of their responsibility for supplying and installing the system confirming to relevant standards and specifications and schedule of work.
- c) In case it is mandatory, as per local by-laws, to get CFO's approval, it shall be obtained by the contractor at no extra cost.

7) <u>CO-ORDINATION</u>

Generally more than one agency are working in the same premises where fire detection system is being installed. It shall be the aim of the agencies that the work of other agency/agencies is not delayed. Full co-ordination & co-operation shall therefore be extended during the execution of work to ensure prompt & quality work.

8) <u>PAINTING</u>

The entire exposed conduit work shall be painted with one coat of primer followed by 2 coats of approved / matching colour synthetic enamel paint with identification of red colour bands at appropriate interval (say 3 meters).

9) COMPLETION DRAWING

- 1) Four sets of following drawings shall be submitted by the contractor on completion of work.
- a) Floor plans showing location of detectors indicating the distances between the detectors.
- b) Floor plans indicating the location of main control panel, local control panels, hooters, manual call points, response indicators etc.
- c) Conduit/wiring layout diagrams clearly indicating details of detectors and other devices connected in particular zone.
- d) Drawing showing general arrangement of main control panels and local control panels.

- e) Control wiring diagram of the main and local control panel.
- f) Circuit line diagram of the power supply unit and the power amplifier.
- 2) Three sets of service and troubleshooting manuals in respect of the installation including salient details of the installation shall be supplied by the contractor.

10) TEST AT SITE

- After physical completion of the installation functional testing shall be conducted by the firm in the presence of Engineer-in-charge or any representative of the department. Functional tests on the following items shall be conducted for this purpose.
- a) Smoke detectors both ionization and photo electric type.
- b) Response indicators.
- c) Duct detectors
- d) Hooters
- e) Stand-by Battery
- f) Heat detectors
- g) Main and Local Control Panels
- Functional acceptance testing will be conducted after successful completion of above test by the Engineer-in-charge or his representative and representative from the T&D circle of the department. Following procedure shall be followed for this purpose.
- a) Each smoke detector shall be tested by putting smoke generated by four Agarbatti Sticks at about 300 mm below the bottom of detector and the detector shall operate within 30 to 60 seconds.
- b) The heat detectors shall be tested by creating a fire below the detector in a bucket or with hot air blower in order to achieve the requisite temperature rise for operation of detector.
- c) All the components like ionization smoke detectors, photo electric smoke detectors, duct detectors, heat detectors main and local control panels, public address system etc, will be tested for their functional performance.

11) TAKING OVER OF INSTALLATION

After the installation has been completed in all respects and acceptance tested successfully as per the procedure laid down above, the same shall be taken over by the department for beneficial use. The minor defects and discrepancies which might be noticed during acceptance testing shall be attended by the contractor within one month from the date of acceptance test.

12) <u>GUARANTEE</u>

The complete installation shall be guaranteed for trouble free operation for a period of 12 months from the date of successful acceptance testing. Any defects discovered or developed

during this period shall be rectified by the firm free of charge including replacement of components if any.

13) MAINTENANCE

1) The contractor shall provide free maintenance of 12 months from the date of successful acceptance testing. This shall include four periodical inspection visits. During this visit the contractor shall inspect the system, adjust necessary controls, if required and satisfy the department that the system is in working condition.

2) The security deposit withheld by the department will be released after four successful visits by the contractor during maintenance and guarantee period of 12 months, 5% of security deposit may be deducted for not performing each such visit.

3) The contractor shall supply two cards of each type in main and local control panels duly accommodated in panels.

14) TRAINING OF DEPARTMENT PERSONNEL

The contractor shall arrange to train the personnel of the department during the execution of work, commissioning of the system and testing of the system on the following aspects of the installation.

a) Operation of system.

- b) Diagnosing & attending to minor faults and defects which might develop during the course of system operation.
- c) Operation and maintenance of power supply unit and the amplifier unit.
- d) Replacement of zonal cards with spares available in maintenance kit.

15) <u>REJECTION OF DEFECTIVE INSTALLATION</u>

The rejected material will be cleared from site immediately on rejection. If the complete system or any part thereof, before it is taken over, be found defective or fails to fulfill the intent of the specification, the contractor shall, on receipt of a written notice from the Engineer-in-charge forthwith make good the defects. Should the contractor fail to rectify the defects and or make good the defective system within a stipulated time mentioned in the written notice or replace the equipments/ components at no extra cost, department may make good, reject or replace the same at the risk and expenses of the contractors, the whole or any portion of the system which is defective or fails to fulfill the requirement of the contract.

16) BYE LAWS

The contractor shall comply all bye laws and regulations of local bodies having jurisdiction over the works and shall be responsible for payment of all fee and other charge giving and receiving all necessary notices and keeping Engineer-in-charge informed about the notices issued and received. The contractor shall get the system/installation approved from concerned fire authorities, when required. Any statutory fees payable shall be reimbursed on actuals. The contractor shall indemnify the department against all claims in respect of patent rights, design, trade mark for name or other protected rights in respect of any components, equipments work or materials used for or in connection with the work and from against all claims demands, proceedings, costs, charges and expenses what-so ever in respect of or in relation thereto. The contractor shall defend all actions arising from such claims and shall himself pay all royalties etc.

17) SPECIAL CONDITION:

(Copy of letter No.23 (7) (1)/CEET (M)/97/ 1062 dated 10/7/97.)

SUBJECT: Compensation to be levied in cases of use of duplicate/spurious material in Fire Detection & Fire Alarm panel, Detectors & all other components of F.D. & F.A. system. "Department reserves the right to get inspected material in Fire Detection & Fire Alarm panel, Detectors & all other components of F.D. & F.A. system and any components thereof by the manufacturer / their authorized representative, whose report as regards to the genuineness of component shall be final and binding. In case any component upon such inspection is found to be duplicate/spurious, double the cost of such component based on price list (without any discount whatsoever) effective on date of aforesaid inspection shall be recoverable.

In case the contractor agrees to replace the components so found spurious/duplicate at his cost, within 15 days of the said report compensation of Rs.1, 000/- per component found spurious / duplicate shall be levied against the contractor.

Besides the above the Department reserves the right to take disciplinary action against the contractor.

Decision of S.E. in such case shall be final and shall be out of purview of clause-25 of arbitration".

18) GENERAL CONDITIONS

The following general conditions of contract are deemed to have been agreed upon.

1) All civil works such as construction of foundation for the equipments with masonary or the steel members as may be required is included in the scope of work.

2) Provision of suitable tripod or any other such stand of 300 mm height for fixing of detectors in false floor is included in the scope of work. The design of the tripod / stand shall be got approved from the Engineer-in-charge.

3) Any damage or breakage which might be caused during the execution of work shall be made good by the contractor at his own risk and cost.

4) The contractor is responsible for the removal of debris and waste materials arising out of the work done by him, from the site.

5) The contractor shall commence the work like laying/fixing/fixing of conduits, fixing of detectors Engineer-in-charge whose decision shall be final and binding.

6) Necessary tools and plants shall be arranged by the firm. Modern tools and equipment shall be need for handling of cables and Machines, drilling, chiseling, cutting etc. so that speed,

accuracy, minimum noise, vibrations and disturbance to the building/occupants/equipments can be achieved.

7. The firm shall submit all the records such as excise. Duty gate pass, test certificate, guarantee cards, operation and maintenance manuals and spares and tools of the original supplier to the department.

8. The firm shall provide necessary barriers, warnings, signals and other safety measures to avoid any accident. The employees of the firm are to be suitably insured against such accidents. The department shall not be responsible for any such accidents.

9. The concealed items like earthing, cabling, conduits etc. shall be carried out only in the presence of duly authorized departmental staff.

10. The offer shall include all charges for packing, handling, freight, insurance, loading, unloading, stacking etc. for the material.

11. Work shall generally be carried out during working hours. However, as per the Departments requirement the working hours shall be extended without any extra claim.

12. All fittings unit assemblies, accessories, hardware foundation bolts, terminal blocks for connections, cable glands and miscellaneous material and accessories of items of work which are useful and necessary for efficient assembly and working of the equipment shall be deemed to have been included within the scope of work in the tender and within the overall details for complete item whether they have been specifically mentioned or not.
