- 1.2 Tenders will be issued to eligible contractors provided they produce proof of their valid enlistment with the appropriate authority and Form A and partnership deed in case of partnership firms.
- 1.2.1 Criteria of eligibility for issue of tender documents for non-DOT/BSNL registered contractors of Public Works Organizations like CPWD, local State PWD (B&R), DOP, MES & Railways only.
- 1.2.1.1 For works upto Rs.7 lakhs-NIL

- 2. The conditions and tender documents can be had on application from the office of the ExecutiveEngineer (Civil), BSNL Civil Division, Dimapur, on payment of cost of tender document (non-refundable) and Earnest Money Deposit in prescribed format as per details given. Accordingly alternative provisions for condition Nos. 4, 10 & 12 of the General Rules and Directions are given in this book. The appropriate alternatives will be applicable in specific cases depending on whether this is used for percentage rate tender (BSNLW-7) or item rate tender (BSNLW-8).
- 2 BSNLW-6, abridged formBSNLW-7/8, Schedules A to F ,Special conditions /Specifications and drawings will be issued to intending tenderers only. The standard form will not be issued along with the Tender Documents but the same shall form part of the agreement to be drawn and signed by both the parties after acceptance of tender. The standard form shall be available in downloadable manner from website "www.ne2.bsnl.co.in"
- 3 All blanks are confined to Notice Inviting Tender(BSNLW-6) and Schedules A to F.
